## TARZANA NEIGHBORHOOD COUNCIL JOINT BUDGET & FINANCE COMMITTEE AND SPECIAL BOARD MEETING Minutes

1. The meeting was called to order at 6:30 PM.

Present were: Harvey Goldberg, Eran Heissler, Sylvia Bedrossian, Varant Majarian, and Bob Shmaeff. Absent were: Mark Epstein, David Gerhardt, Leon Gonzalez, and Ken Schwartz. Pam Majumdar informed Harvey that she has moved from Tarzana and would no longer be a committee member.

- **2.** There were no public comments.
- **3.** The minutes of March 20, 2024 meeting were approved on a motion made by Eran and seconded by Varant. The motion was approved unanimously.
- **4.** Eran made a motion and Bob seconded, to approve the March 2024 expenditures for submission to City Clerk (MER) and Financial Statements as of March 31, 2024. The motion was approved unanimously.
- 5. Sylvia moved and Varant seconded a motion to approve a request from Outreach Committee to purchase 1,000 reusable shopping tote bags with TNC logo and website for \$1.49/each plus print setup, shipping and tax. Total cost NTE \$1,850.00. To be classified as Outreach, Advertising, General Promo Items. Funds to come from Unallocated. The motion was approved unanimously.
- 6. Eran moved and Varant seconded a motion based on an update from Harvey to approve a request from Beautification Committee to purchase 50 (25 pairs) banners for installation on light poles in Tarzana from Gold Metropolitan Media at a total cost of \$5,629.38. In addition to \$200 for the repair of 14 banners (7 pair) and \$660 to install the 14 repaired banners and 4 new banners in inventory and \$990 for 12 months of service to maintain these banners and all others that are currently in place. Total cost NTE \$7,500.00 To be classified as Outreach, Advertising, Banners. Funds to come from Unallocated. The motion, as amended, was approved unanimously.
- 7. Varant moved and Sylvia seconded to approve a request from our President to purchase two (2) Zoom licenses to facilitate Zoom meetings at a cost of \$220/each. Total cost NTE \$490. To be classified as Operations, General, Meeting Expenses. Funds to come from Unallocated. The motion was approved unanimously.
- 8. A request from Tarzana Elementary School for a NPG for \$2,047.95 to fund the Renaissance Star Reading Program for the 2024-25 school year was tabled since the final NPG was not submitted.
- **9.** There was no other committee business. The next meeting, tentatively, was scheduled for Wednesday, May 22, 2024 at 7:00 PM. Agenda items for the meeting should be submitted by Wednesday, May 15, 2024.
