**6. 5431-5505 Reseda Mixed Use Update**. Director's Determination and TPOA Appeal: Mixed use with 2546 square foot commercial and 40 residential units.

**7**. **SB 330 and SB 592 Update.** State Senate bills SB 330 and 592 would place restrictions on development standards, essentially removes local control of zoning, allow community commercial projects in residential areas, and limitss local government ability to review proposed structures and property zoning changes.

**8. Home Sharing Ordinance Update:** The ordinance has been approved by the City and went into effect in July. Registration begins in November.

**9. Community Plan Update.** The Planning Department has adopted TNC recommendation that the northern boundary of the plan in Tarzana be extended to Victory Boulevard.

**10. Linkage Fee Update**. The Linkage Fee ordinance passed on December, 2017. A new set of fees was adopted on July 1, 2019 for construction depending on the area and type of construction.
