- **7. Billboard Blight**: A proposed major revision to the earlier version has been sent from the City Planning and Land Use Committee to the full City Council. It removes essentially all restrictions on billboards and other signage. Discussion and possible motion.

SB 330**, **SB 592**, **and SB50 Update.** Governor Newsom has signed SB 330 which places restrictions on development standards, essentially removes local control of zoning, allows community commercial projects in residential areas, and limits local government ability to review proposed structures and property zoning changes. SB 592 and SB 50 have been placed on hold.
