#### SAVE A DOG'S LIFE OVER THE 4TH OF JULY HOLIDAY

Dogs are very fearful of fireworks. Please make sure that your dog is secure during the 4th of July period, as dogs often run away when they hear loud noises like fireworks. Please check your yard to make sure there is no way for your dog to get away. And on the evening of the 4th, if you are out at a fireworks display, it is best to keep your dog in the house so there is no chance of it running away. The same is true of cats and other animals.

Los Angeles City Animal Shelters receive a large temporary influx of dogs (and to a lesser extent cats) over the 4th of July period. This influx starts in late June, when people start setting off fireworks. Citizens who find run-away dogs, as well as City Animal Control Officers who catch them, bring them into the Shelters to care for them. Most of these animals are redeemed by their owners within several weeks. But while they are at the Shelter, they occupy a kennel, which can cause overcrowding at the Shelters. In the past, if the Shelter became overcrowded, dogs would be killed to make room for these new dogs coming in.

We are implementing a "Temporary Animal Foster Parent Program" at the West Valley Shelter, to prevent the killing of any healthy adoptable dogs over the 4th of July period for lack of space. Members of the public will be able to foster a dog (or cat) in their homes for several weeks during the 4th of July period if kennel space is needed.

is approved by the Los Angeles Animal Services Department, you will be placed on a list and will receive an email from the Shelter if there is a need for temporary fosters. If you foster a dog and it ends up that you want to keep the dog permanently, you can go through the adoption process. Otherwise, the dog will be returned to the Shelter.

#### **VOLUNTEER FOSTER PARENT AGREEMENT**

As a Volunteer Foster Parent (VFP) for the Los Angeles City Department of Animal Services (LAAS) you are required to abide by the terms of the Volunteer Foster Parent Agreement.

If accepted as a Volunteer Foster Program Volunteer and in consideration of becoming such, my initials and signature below indicate that <u>I understand and agree</u> to the following.

 All potential (VFP) must attend a Bottle Baby Foster training/orientation, if applicable.
 Once a fostered animal is weaned (8-10 weeks) it must be returned by the VFP to the animal care center and re-booked into the system.
 Each and every adoption of a fostered animal must be processed at one of our care centers and is subject to the guidelines for the Foster Program.
 Foster Parent Volunteers are required to sign in and out in the Log Book each time they visit a center with an approximately number of hours caring for the foster animals.
 Foster Parents agree to provide time, proper and sufficient food and water, shelter, kind treatment, and proper veterinary medical care (provided by the Animal Care Center) for the animal(s) in my care, at all times.
 LAAS makes no guarantees, whatsoever, as to the adoption, health, temperament, mental disposition, and training of the animals.
 LAAS will be allowed to reasonably inspect the premises in which the animal(s) will be/are maintained, from time to time, for the purpose of determining the suitability of those premises for the care and maintenance of the animal(s).
 If I fail to abide by the terms of this Agreement or otherwise fail to satisfy LAAS' requirements, as determined by LAAS at its sole discretion, I will be terminated from the LAAS Foster Program and all LAAS animals will be returned to a LAAS care center immediately.
 Foster animals are only temporarily in my care, remain the property of the LAAS and are subject to relinquishment at any time. Failure to return a foster will result in termination, a "do not adopt" status and possible legal action.
 I agree that I will not relinquish custody of the foster animal(s) to anyone except LAAS.
 LAAS requires that the foster(s) remain in my care the entire time they are being fostered. If I cannot continue to care for the foster animal(s) for any reason, even temporarily, I shall return the animal(s) to one of the LAAS care centers. The animal(s) will not necessarily be returned to me.

Hi Brenda. Thank you for your attention to this matter.

I want to let you know that Rockin' Rescue is pursuing the zoning variance vigorously and has been completely successful so far in this process. It is, unfortunately, a long process with several hearings. This is what has happened so far.

- 1. On October 13, 2015, the Tarzana Neighborhood Council Animal Welfare Committee unanimously passed the following resolution. A copy of this Resolution is attached at pages 5 and 6, paragraph 7:
  - "Resolved that the Tarzana Neighborhood Council Animal Welfare Committee recommends that the Tarzana Neighborhood Council assist Rockin' Rescue in obtaining the change of use/zoning necessary to obtain a kennel permit."
- 2. At its October 27, 2015 meeting, the full Board of the Tarzana Neighborhood Council unanimously adopted the following resolution, which is at page 7 of the attached materials, paragraph 8:
  - "Resolved: The TNC approves the Animal Welfare Committee recommendation that the Tarzana Neighborhood Council assist Rockin' Rescue

# in obtaining the change of use/zoning necessary to obtain a kennel permit." The motion carried unanimously.

- 3. Pursuant to these Resolutions, I and other members of the Tarzana Neighborhood Council Animal Welfare Committee, as well as Tarzana Neighborhood Council President Leonard Shaffer, appeared at the Woodland Hills Warner Center Neighborhood Council (WHWCNC) PLUM Committee and full Neighborhood Council meetings, to speak in favor of the Variance. Volunteers from the West Valley Animal Shelter, Chairperson Debbie Kozin of the Sherman Oaks Neighborhood Council Animal Welfare Committee, and other supporters of Rockin' Rescue were also at the meetings. We presented a Petition supporting Rockin' Rescue's application, with over 200 signatures obtained in about 2 weeks.
- 4. On January 13, 2016, the Woodland Hills Warner Center Neighborhood Council unanimously voted in favor of the Variance, with two conditions consented to by Rockin' Rescue. The letter from the WHWCNC to the Los Angeles City Planning Department, dated January 15, 2016 (mistakenly shown as 2015), is page 11 of the attached materials. The letter states: "After a presentation by the Applicant, the Neighborhood Council Board voted to approve both the Use Variance and the Parking Variance, with the following conditions consented to by the Applicant: ..."
- 5. On March 11, 2016, a hearing was held before the Department of City Planning. Over 350 signatures on the Petition in support of the variance, the resolutions in support of the variance by the Woodland Hills Warner Center Neighborhood Council and the Tarzana Neighborhood Council, and other documents in support of the variance, were presented at this hearing. Andrew Pennington, Senior Planning Deputy for Councilman Bob Blumenfield, also spoke in favor of the variance. The Hearing Officer took the matter under consideration.

As you can see, there is *overwhelming community support for a variance* that will allow Rockin' Rescue to continue to operate at its current location, saving the lives of dogs and cats in our community, and providing a place where people can adopt rescued pets. But unfortunately, the zoning variance process is a long one, even in a situation such as this where there is so much community support. After the report of the Hearing Officer is issued, the Planning Commission, as well as the City Council, still have to consider the matter, which is going to take several months longer.

So thank you for your patience on this, and please inform the appropriate staff of your earlier instruction that the Department will monitor only, so long as the animals look well cared for and they are still moving forward with their zoning request. Please make sure that the Administrative Citation that was issued to Ady Gil (DAS#0006161) is rescinded. I am and will continue to be personally involved in moving Rockin' Rescue's zoning request forward as quickly as possible. I also stop by Rockin' Rescue on occasion, to say hello to the dogs there (some of whom came from the West Valley Shelter), and can assure you that the animals look very well cared for.

I DID NOT "reply all", and not sure of the Brown act, but I am going to CC all the commissioners as they should be aware of the department constant harassment against a rescue that actually makes the department "numbers" better and help, without the city or taxpayer's money, to achieve a No Kill LA by 2017, while the city does whatever it can not make sure it is hard for us to save animals, by wasting my time writing this email, as an example, or giving us a \$200.00 fine.

Instead, it would have been nice and polite to send us a "Thank you" letter after I personally delivered with my truck 1,000 lbs (one thousand pounds) of dog treats to LAAS West Vally facility, 3 weeks ago, as a gift.

#### Commissioners,

I checked into the concerns expressed by Rockin' Rescue supporters, employees and founder at the Commission meeting last evening.

What I learned is that an officer has been there on more that one occasion. Ady Gil, or someone at Rockin' Rescue, has been advised that they cannot have a kennel permit until they are properly zoned.

#### Basically,

- 1. as long as the animals look well cared for,
- 2. and they are still moving forward with their zoning request

#### the Department will monitor only.

If the animals were to be found in poor condition, or if the zoning request to use as a rescue shelter is denied, or if they halt efforts to get proper zoning, we would give them notice to comply with the 3 dog and 3 cat limit. Otherwise we will just continue to monitor as they go through the zoning process .
