4) Please describe the purpose and intent of the grant.

The Tarzana NC and West Valley~Warner Center Chamber of Commerce are co-sponsoring the 4th Annual Earth Day Celebration & Poster Contest on Saturday April 18, 2015 at the Tarzana Park.
