- 8. Discussion and motion: Resolved: The TNC Board approves the Budget Committee's recommendation to reverse previously budgeted but unneeded expenditures for the FYE June 30, 2016 as follows: Operations \$1,422.96; Outreach \$4,938.99; Community Improvement Projects \$1,200.00; Elections \$5,787.20. - **16.** Discussion and motion: Resolved: The TNC Board approves the filing of a CIS supporting Council File 16-0093 as follows:
  - 1. The Tarzana Neighborhood Council supports the recommendations of the DWP (MOU Oversight Committee and the DWP (Advocacy) Committee regarding the reform and restructure of the Department of Water and Power.
  - 2. We support a fiduciary Board of Commissioners consisting of seven (7) qualified members appointed by the Mayor and confirmed by the City Council, serving staggered terms who may not be removed except for cause.
  - 3. We oppose a full, time, paid Board of Commissioners. However, Commissioners would be entitled to reasonable per diem fees.
  - 4. The Board would appoint the General Manager, determined policy, and establish rates.
  - 5. The City Council would have the right to assert jurisdiction in certain matters, including rates, only for the purpose of affirming or denying the action by a supermajority vote.
  - 6. The Board would be assisted by a more robust Ratepayers Advocate.
  - 7. Contracting and procurement policies would be modified allowing the Department more flexibility.
  - 8. The Department (DWP) would be responsible for labor negotiations.
  - 9. The Department (DWP) would establish its own Human Resources Department, separate and distinct from the City's Personnel Department. DWP would not be subject to the City's civil service rules.
  - 19. The Transfer Fee would be subject to a City wide vote.
- 17. Discussion and motion: Resolved: The TNC approves the Land Use Committee's recommendation to support the Plan approval application to demolish an approximately 2,800-square foot existing tennis clubhouse and replace it with an approximately 4,307-square foot, 19-foot maximum height, 1-story new tennis clubhouse on the premises of Braemar Country Club at 3951- 4015 Reseda Blvd.
