Resolved: The Tarzana Neighborhood Council supports the Los Angeles City Council's motion to include in its 2019-2020 State Legislative Program OPPOSITION to SB 50 (Wiener), which would which would essentially eliminate the City's ability to control zoning in residential, commercial, and mixed use zones and allow the construction of taller and higher-density multi-family housing developments near major transit stops and job rich areas that are out of compliance with local land use regulations and procedures, unless amended to exclude the City of Los Angeles from its provisions. The Tarzana Neighborhood Council supports this effort in part based on the City's own programs to encourage increased residential density near transit through efforts such as Measure JJJ.
