Dear Congressman Sherman:

Thank you for speaking at the Tarzana Neighborhood Council meeting last Tuesday (October 26). It was very good speaking with you about the Dog Meat Trade in South Korea, in which millions of dogs and cats are tortured, killed, and eaten every year.

This email is to provide additional information, to help you and your staff carry out your commitment made at the meeting to broaden the relationship you have with South Korean legislators to focus on the dog meat issue, and leverage those relationships to help end the dog meat trade in South Korea.

As I noted, it is the **official position of the City of Los Angeles** to oppose the Dog Meat Trade. **The City Council unanimously passed a resolution opposing the dog meat trade** and stating that the City will "SUPPORT ... legislation or administrative action that would request the governments of China, Vietnam, South Korea, Cambodia, and Indonesia to ban the sale of dog meat and to enforce their animal cruelty laws." The official position of Los Angeles is set forth in City Council File 19-0002-S101 (sponsored by Councilmembers Blumenfield and Ryu), attachment 1 and here: https://cityclerk.lacity.org/lacityclerkconnect/index.cfm?fa=ccfi.viewrecord&cfnumber=19-0002-S101 This is also the position of the Valley Alliance of Neighborhood Councils, representing all 34 Neighborhood Councils in the San Fernando Valley. As we discussed, on September 25th, South Korean President Moon Jae-in told the Prime Minister: "Hasn't the time come to prudently consider prohibiting dog meat consumption?" There is a bill pending in the South Korean National Assembly to do just that, Bill Number 7035—Proposed Partial Amendments to the Animal Protection Act, introduced and sponsored by Minister of Environment Han Jeoung Ae along with nine other Assembly members. As we discussed at the meeting, a letter, call, or email from you to fellow legislators in South Korea, urging support for this bill, could aid in the passage. You could also speak or correspond with the South Korean Ambassador to the United States, Lee Soo Hyuck Lee (https://overseas.mofa.go.kr/us-en/index.do), or the Consul General of South Korea in Los Angeles, Kyung Jae Park (https://overseas.mofa.go.kr/us-losangeles-en/index.do). It certainly would be fitting and proper for you to engage in such communications, since it is the official position of the City you represent to oppose the dog meat trade and to "SUPPORT ... legislation or administrative action that would request the governments of China, Vietnam, South Korea, Cambodia, and Indonesia to ban the sale of dog meat and to enforce their animal cruelty laws." Raising this issue in any meetings or conversations you have with officials, business persons, or others from the countries involved in the dog meat trade could also be impactful. You could inform such persons that it is the official policy of the City of Los Angeles (a major trading partner with all the countries involved in the dog meat trade) to oppose the dog meat trade. Helping Korea end the dog meat trade is in fact helping the Korean nation and its people. As long as this practice continues, it will be a highly contentious element in their society, a hindrance to their progress, and an ethical stain and embarrassment for their people. (There were over 500 public comment submissions to the City Council

when it considered the Dog Meat Resolution, all of them in favor of the resolution. Those comments convey the depth of people's feelings about the Dog Meat Trade. In fact, South Korean President Moon has stated that dog meat is becoming an international embarrassment.

So as we discussed, now is a really opportune time for you to contact your fellow Korean legislators and other Korean officials, and urge them to support the bill banning dog meat, and let them know what the official position of Los Angeles is on the torture and killing of dogs and cats. On behalf of the dogs and cats of South Korea, thank you for your commitment to do so at the Tarzana Neighborhood Council meeting on October 26.

Attachment 1 – LA City Council Resolution Opposing Dog Meat

RESOLUTION

WHEREAS, any official position of the City of Los Angeles, with respect to legislation, rules, regulations or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, in recent years the City of Los Angeles has been one of California's leaders in pursuing progressive animal welfare policies and practices; and

WHEREAS, it is estimated that 10 to 20 million dogs in China, 5 million dogs in Vietnam, and one million dogs each in South Korea, Indonesia, and Cambodia are killed for food each year; and

WHEREAS, dogs in these countries are kept in cramped, rusty cages stacked on top of each other, and slaughtered in brutal ways such as hanging or electrocution, due to an erroneous belief that high adrenaline levels will produce tender meat and increase the supposed health benefits of consuming dog; and

WHEREAS, the governments of some of these countries have passed laws regarding dog meat and animal cruelty: in China, the Food Safety Law of the People's Republic of China, and in South Korea, the Animal Protection Act; and

WHEREAS, despite laws regulating the sale of dog meat in these countries, dog farms continue to operate in brazen disregard of any established standards of animal cruelty, and continue to raise and slaughter dogs in inhumane ways;

NOW, THEREFORE BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes into its 2019-2020 Federal Legislative Program SUPPORT for legislation or administrative action that would request the governments of China, Vietnam, South Korea, Cambodia, and Indonesia to ban the sale of dog meat and to enforce their animal cruelty laws.
