Dear: Mr. Goldberg and Executive Board Members of Tarzana Neighborhood Council:

This letter addresses the need for the students at Portola Middle School to have the equipment necessary to facilitate the newspaper club. The newspaper club was started on or about 3/1/22. The students got 10 members to join and the club is sponsored by Mrs. Miller. The Students were anxious to report on daily events occurring in and around school and the community of Tarzana.

They need the following equipment to facilitate publishing the newspaper. They first and foremost need a printer that is color and will accommodate big size paper so the students can fold it and distribute it like a newspaper. The color printer with the ink will facilitate color pictures to show if someone is retiring or the ABC news was present talking to students in regards to mask mandate or no mask mandate. The pictures will be in color so more people will enjoy reading it. The camera is needed to take the pictures necessary on reporting certain events where a picture is worth a thousand words. The camera is a canon DSL to be compatible with computers and printer. This camera is pretty expensive however the students will use it throughout as it belongs to the newspaper club which can report on all neighborhood events, talent shows, business events, and school current events.

The newspapers will be available for everyone in the community and neighborhood. There is an editorial area for all who wish to state their opinion. The newspaper will help facilitate common ground. The students have been in isolation for over 2 years with no interaction with other students and they have lost the art of communication and how to get along with their peers and neighbors. This will help all the students to interrelate with each other these topics will open up the line of communication and conversation. It will educate the students immensely. The neighbors will benefit as well because they are part of the community. The students will leave the newspapers in common areas of the businesses around Tarzana as long as the Businesses approve. This will give the community a voice and maybe mobilize if change is needed in the community.

Thank you for considering this grant and hopefully approving it as there is no other funding to help support the newspaper club at Portola Middle School.
