General Public Comment: Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Board.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Every Member of the City Council has an obligation to ensure that our constituents can have confidence that we will serve each of them with equity, fairness, and dignity, and that no resident of our city will be mistreated or excluded because of their identity.

During a meeting of the above City Council Members and a local labor union leader discussing redistricting in October 2021 the Members engaged in racial slurs against African Americans and hateful remarks regarding LGBTQ, another Council Member's son, Jews, Armenians, and indigenous persons.

The hateful comments of those City Council Members have created a toxic climate that needs to be healed. It is inconceivable that the City Council can attend to the City's business if any of the three Members continue to retain their Council seats. Healing can only begin with the resignation of all three of the Council Members.
