IN CONFORMITY WITH THE SEPTEMBER 16, 2021 ENACTMENT OF CALIFORNIA ASSEMBLY BILL 361 (RIVAS) AND DUE TO CONCERNS OVER COVID-19, THE COMMITTEE MEETING WILL BE CONDUCTED ENTIRELY WITH A CALL-IN OPTION OR INTERNET-BASED SERVICE OPTION.

Public Comment: Every person wishing to address the Committee must dial (1-669) 900-6833 and enter 870 7491 9685, then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Committee meeting the public will be requested to dial *9 or u se the Raise Hand option, to address the Committee on any agenda item before the Committee takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

General Public Comment: Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Committee meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Committee.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting; only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Any messaging or virtual background is in the control of the individual Committee member in their personal capacity and does not reflect any formal position of the Committee or the City of Los Angeles.

allocated in one (1) minute increments. In no event shall time be allocated for less than one (1) full minute. The above time limitations are subject to adjustment by the presiding officer in conformity with the Brown Act.

- 2. Public Comments Comments from the public on non-agenda items within the Committee's subject matter jurisdiction. General Public Comments are limited to two minutes per speaker.
- **3.** Updates and discussion and possible motions on the following matters:
 - a. Quorum for the Animal Welfare Committee. Discussion and possible motion: Reduce the quorum for the Animal Welfare Committee from 7 to 5.
 - b. Sepulveda Basin Dog Park and proposed bike path. Discussion and possible motion: Resolved: The Tarzana Neighborhood Council Animal Welfare Committee (TNC AWC) requests that the TNC Board pass a resolution "Against Unless Amended" for Council File 22-0247, entitled "Los Angeles River Valley Bikeway and Greenway / Vanalden Avenue / Balboa Boulevard / Mitigated Negative Declaration Certification." The amendments requested are to preserve the Sepulveda Basis Dog Park in the following regards:
 - 1. None of the land of the Dog Park is taken for the bike path.
 - 2. No trees, especially shade trees, in or adjacent to the Dog Park are removed.
 - 3. The Dog Park is not closed during construction.
 - 4. The bike path has sufficient separation from the Dog Park so that dogs in the park will not chase bikes along the fence line, causing injury to other dogs or people in the Dog Park.
 - 5. The parking lot for the Dog Park not be used as an entry or exit for the bike path, which will cause bikes and pedestrians walking or running through the parking lot to interfere with dog owners getting their dogs into and out of the Dog Park. This is a safety issue; dogs may try to chase bike riders in the parking lot, causing injury to people and dogs.
 - 6. The parking lot for the Dog Park, which is already insufficient for users of the Dog Park during certain times, not be used as a parking lot for bike riders and walkers on the bike path. Users of the Dog Park already have to park on grass areas during times of peak use.
 - 7. Before any plan for the bike path is approved and before construction begins, users of the Dog Park, the organization Friends of the Sepulveda Basin Off-Leash Dog Park, as well as the impacted Neighborhood Councils, should be given an opportunity to provide input, at a town hall or other meeting. Hundreds of local residents regularly use the Dog Park and have not been given an adequate opportunity to provide input. There are alternatives to the current plan which have been developed by users of the Dog Park, such as continuing the bike path south of the Los Angeles River, which have not been given a hearing.
 - 8. It is also suggested that lights be put into the Dog Park.
 - 9. The letter from Friends of the Sepulveda Basin Off-Leash Dog Park will be attached to the Community Impact Statement.

c. Update on Opposition to the Dog and Cat Meat Trade. Discussion and possible motion: Resolved: The Tarzana Neighborhood Council Animal Welfare Committee (TNC AWC) requests that the TNC Board pass a resolution for a Community Impact Statement (CIS) "For" Council File 19-0002-S101, which was passed by the Los Angeles City Council and signed by the Mayor, requesting the governments of China, Vietnam, South Korea, Cambodia, and Indonesia to ban the sale of dog meat and to enforce their animal cruelty laws.

The Tarzana Neighborhood Council Animal Welfare Committee (TNC AWC) requests that the TNC Board pass a resolution for a letter to be sent to Councilman Blumenfield, asking him to introduce a City Council resolution supporting AB 240, entitled "Dogs and cats: California Spay-Neuter Fund." AB 240 provides for a charge on manufacturers of dog and cat food, the money to be placed into a fund for spay/neuter of dogs and cats. Spay/neuter is the humane way to deal with overpopulation of dogs and cats; AB 240 also points out that "[w]hile the average low-cost estimate to spay or neuter an animal is \$160, it costs an average of \$2,000 to control, house, care for, adopt out, and/or euthanize an animal." Failure to provide adequate funding for spay/neuter is penny wise and "pound" foolish.
