If multiple speaker cards are submitted on one agenda item, preference will be granted to members of the public who have not spoken previously during the meeting, either during public comment or on another agenda item.

Comments from the public on other matters not appearing on the Agenda that are within the Committee’s subject matter jurisdiction will be heard during the Public Comment period. Public comment is limited to 2 minutes per speaker, unless waived by the presiding officer of the Committee.

Long range; advocate to expand state & federal funding for affordable housing and homeless services, advocate to limit rent increases, to prevent unjust evictions, and do more to help other communities say yes to supportive, bridge & interim housing
