### ECTION II - PROJECT DESCRIPTION

4) Please describe the Neighborhood Improvement Project for which the grant is intended.

This project is about creating and providing quality live theatre presentations in Tarzana for both adults and children at the new San Fernando Valley Arts & Cultural Center (The Center). Currently The Center is open for visual and fine arts exhibitions and workshops. Work has recently begun on the performing arts space requirements. Presentations for students will be done on a "suggested donation" basis at The Center. Children from low income families will be allowed to see the productions for free, if they choose. On Saturday afternoons, a family production along educational lines will be presented. It will be supervised by adults, so that parents can feel safe about their children attending. While the Center is for the whole Valley, Tarzana students can easily be dropped by their parents at the Center, knowing that their children are in a safe educational environment. In the evenings, plays, musical concerts, and lectures will be presented in the new theatre space. This grant will be used to provide high quality lighting for all the live presentations. Good lighting is essential for live performances. Since the San Fernando Valley Arts & Cultural Center is a venue for all forms of art, the theatre space is not isolated in a separate area. Therefore, it is critical that the technical production aspects, such as lighting, are as professional as possible. Lighting will help create the boundaries of the performance space, change mood, atmosphere, and location - and enhance the overall visual effects of each production.

5) How will this grant be used to primarily support or serve a non-discriminatory, public purpose and benefit the public at-large.

Although larger performing arts venues exist in the Valley, there is no space in Tarzana that integrates the visual arts and the performing arts for the general public in an intimate setting. There is ample parking available at the new Arts Center, and it is directly across from the Orange Bus Line. This will provide a significant economic boost to Tarzana as the area expands and offers more opportunities for additional business as well as arts and cultural events. Patrons of The Center from all over the Valley will have the opportunity to experience Tarzana's neighborly atmosphere, shop at stores near The Center and eat at nearby eateries. This venue provides access to sorely needed space for workshops, rehearsals, classes, lectures, exhibits and live theatre for all residents of Tarzana at reduced rates. Dramatic presentations for all age groups will be presented in the theatre space, from productions for children to seminars on the Art of Creative Aging. Those residents who currently drive "over the hill" to see arts events can now stay in their own community to support and experience live arts events. Theatre classes will be conducted at The Center, where students can learn not only acting, but technical production elements (such as lighting) first hand.


