Whereas the Tarzana Neighborhood Council is aware that the posters and the sign defacement contain information that is Anti-Semitic and were posted for the purpose of causing distress and fear in Tarzana's Jewish community, and

Whereas the Tarzana Neighborhood Council believes that if it remains silent in the face of these hateful activities it will be to the detriment of all the individual communities that make Tarzana a desirable place to live and work.

Now therefore, the Tarzana Neighborhood Council board resolves as follows:

Resolved, the Tarzana Neighborhood Council strongly and unequivocally condemns anti-Semitism, including the swastika that was painted onto a traffic sign at the corner of Reseda Blvd and Rosita St, in Tarzana. The TNC requests that the LAPD vigorously investigate all anti-Semitic acts taking place in Los Angeles, including the recent acts in Tarzana and other areas of the San Fernando Valley.
