**Public Comment:** Every person wishing to address the Beautification Committee using a phone must call in using the information above to join the meeting. Instructions on how to sign up for public comment will be given to listeners at the start of the meeting. The public is requested to dial \*9, when prompted by the presiding officer, to address the Board on any agenda item before the Committee takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Speakers shall limit their comments to matters relevant to the item on the agenda. The Chair may rule that the speaker is out of order if the comments are not germane to the item under consideration. If multiple speaker cards are submitted on one agenda item, preference will be granted to members of the public who have not spoken previously during the meeting, either during public comment or on another agenda item. Public comment will be limited to 2 minutes unless adjusted by the presiding officer

**General Public Comment:** Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Committee meeting. Public comment may be limited to two minutes per speaker, unless adjusted by the presiding Committee Chair

2. **Public Comments:** Comments from the public on non-agenda items within the Committee's subject matter jurisdiction. Public comments are limited to two minutes per speaker.
3. **Sign Ordinance update:** In late 2019 the Los Angeles City Council directed the Los Angeles City Planning Department to revise the proposed Sign Ordinance. The Planning and Land Use Committee (PLUM) has proposed major changes to the Version B+ of the Citywide sign ordinance which was recommended by the City Planning Commission in 2015. The Tarzana Neighborhood Council supported it. Presentation by Patrick Frank of Scenic Los Angeles. Discussion and possible motion.
4. **5300 Mecca Micvah:** Proposal to establish a micvah (religious ritual bath) and single family residence on a property currently zoned for single family residence. Presentation by representative Stacey Brenner. Discussion and possible motion.
5. **Berrgruen Institute update:** Update of revised application of the Proposed Project. Discussion and possible motion.
6. **State Housing Bills Update:** State legislative bills SB 9 (previously SB1120) and 2B 10 (previously SB 902) have been reintroduced to the current session of the State Senate. SB 10 would allow up to 10 apartment buildings on transit rich/"high opportunity" R and C lots. SB 9 would allow up to 8 dwellings on single family lots. The Los Angeles City Council has voted to oppose the bills. Discussion and possible motion.
7. **Digital Signage at Bus Stops Update:** The Board of Public Works recently released a Request for Proposal (RFP) to implement new shelters at bus stops. The shelters would provide better shade and would include digital signage which would contain advertisements which change every eight seconds. Discussion and possible motion.
8. **Cabin Community Update:** Additional information has become available including cost per unit and how long the communities will continue to operate. Discussion and possible motion.
