- **4. Build With Strength**. Proposed ordinance to require concrete or treated wood in 1 to 7 story buildings. Presentation by representative. Discussion and possible motion.
- **5. SB 827.** Proposed State Senate bill to override City zoning provisions and allow significantly higher buildings with greater floor area density, smaller setbacks, and greatly reduced parking in areas within ½ mile of a major transit stop or ¼ mile of a high quality transit bus stop. Multi-community committee in formation to urge legislators to object to/defeat proposed legislation, Discussion and possible motion.
- **6.** Community Plan Update. Provisions of the Encino-Tarzana Community Plan, West Valley Community plan, Transit Oriented Community Ordinance, Orange Line Plan, Hillside Ordinance, RECODE LA are being combined into a single overriding ordinance. Subsets include open space, equine, and hillside. Discussion and possible motion.
- **7. Mixed Use Project at 19336-19360 Ventura Boulevard**. Proposed demolition of existing car wash and other buildings and construction of a mixed use project consisting of 59 dwelling units and 9255 square feet of commercial development. A Community Forum is being organized by the developer on April 3. Time and location to be announced. What role should TNC play in the forum. Discussion and possible motion. The traffic report is not yet available, so no new general discussion on the project.
- **8.** Mixed Use Project at 6916-6938 Reseda Boulevard. 158 residential units and 13,413 square feet of commercial. Of-menu requests: 2.931:1 FAR of vs permitted 1.5:1; 61 feet vs 45 feet height permitted.
- 9. Short Term Rentals. Possible changes in the duration of rentals. Discussion and possible motion.
- 10. Sidewalk Vending. Possible changes in proposed ordinance. Discussion and possible motion.
- 11. Noisy Residences, ADUs updates.
- 12. Adjournment
